




Supplies: We provide you with two-part prescription sheets, mailing boxes and packing material free of charge.

PREPARATION GUIDELINES



Feather or Chamfer margin with minimum .75 - 1.5mm reduction.



Chamfer or Shoulder margin 1.5 - 2mm reduction.

MATERIALS REQUIRED:

1) Crowns:

Silicone or polyether "PLUG" impression of prepared tooth. Stone model of upper & lower arches (post preparation) and wax bite registration.

2) Orthodontic Appliances and Implants Evaluation:

Silicone or polyether impressions of each arch, including a full arcade of posterior teeth, or stone models of same, wax bite registration and thorough description of malocclusion and desired outcome. Photos and drawings appreciated.
